Protests & Crowd Management Systems (Item 3b)

Meetings to be held on the fourth Wednesday of each month 6:30-7:30pm

Session 1: [Wed., Dec. 22] Topic: Current Law and Policies Regarding Lawful Protests

Listening session explores current policies surrounding Lawful protests and how that law is enforced. Would like to gain insight on policies regarding the use of body cameras and how that policy is enforced (i.e., require carrying spare batteries for body cameras). From an accountability perspective, the discussion will also explore the role of Emergency Response and Third-Party agencies working in tandem during protests to ensure measures are in place to avoid creating situations that precipitate confrontation (i.e., avoid officer deployment in the path of peaceful protestors).

Recommended Presenters: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities).

Session 2: [Wed., Jan. 26] Topic: Unlawful Protest

Listening session explores the protocols and required to declare a protest unlawful. Explore current policies surrounding required variables that determine when a peaceful protest is no longer lawful. How are these policies created? How often are they amended? What are the laws on state- and national levels?

Recommended Presenters: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities).

Session 3: [Wed., Feb. 23] Topic: Unlawful Protest Policies

Listening session explores the policies in place once a protest is declared unlawful. How is this information distributed?

Recommended Presenters: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities).

Session 4: [Wed., March. 23] Topic: Rules and Policies Regarding the Use of Curfews and Safe Exit Plan

Listening session explores what happens once a protest has been declared unlawful. What

contingency plans are in place to ensure the overall safety of protestors, law enforcement, community members, and local businesses.

Recommended Presenters: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities), local business owners, and community members.

Session 5: [Wed., Apr. 27] Topic: Notifications to Businesses of Protest Activity

Listening session explores the current policy with respect to notifying businesses of potential and active peaceful protests that may disrupt businesses. Explore how communication with businesses is monitored to ensure support and/or compliance to avoid potential disruption. **Recommended Presenters**: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities), members from SM Chamber of Commerce, local business owners, and community members.

Session 6: [Wed., May. 25] Topic: Crowd Management Tools

Listening session designed to gain insight into policies regarding specific crowd management tools used by law enforcement and third-party agencies to subdue unlawful protestors. Based on OIR recommendations, discuss tools that have been deactivated and/or implemented to assist with de-escalation.

In addition, the following listening sessions allow for deeper dives into specific crowd management tools:

- 1. Session 6-A. [Wed., Jun. 22] Tear Gas
- 2. Session 6-B. [Wed., Jul. 27] Pepper Spray
- 3. Session 6-C. [Wed., Aug. 24] Projectiles
- 4. Session 6-D. [Wed., Sep. 28] Flashbang grenade

Recommended Presenters: SM City Attorney, SMPD, Emergency Response Team, ACLU (or comparable outside agency), Inspector General (provide current policies in comparable cities), and community members.

Session 7. [Wed., Oct. 26] Topic: De-escalation Policies for Lawful Protests

Listening session explores current policies and training in place to address de-escalation with respect to new implementations following OIR recommendations. Discuss frequency of deescalation training and how successful training outcome is measured.
