 - a. PART ONE: PROTESTS (6:30PM)
 - i. Topic: Current Law and Policies Regarding Lawful Protests (Continued) Listening session explores current policies surrounding Lawful protests and how that law is enforced. From an accountability perspective, the discussion will also explore the role of Response and Third-Party agencies working in tandem during protests to ensure measures are in place to avoid creating situations that precipitate confrontation (i.e. avoid officer deployment in the path of peaceful protestors).

 - i. **Topic: Routine Traffic Enforcement (Continued)** Listening session will explore pros and cons of decoupling local police from the function of routine

traffic enforcement. What are the issues that underly the widespread interest in this among police reform academics and advocates? Are there appropriate alternatives to sworn police officers conducting routine traffic enforcement? What are the budgetary implications of potential change? Attendance of internal experts from SMPD and the City Manager's office has been requested. The participation of external experts may also be included in the meeting.
