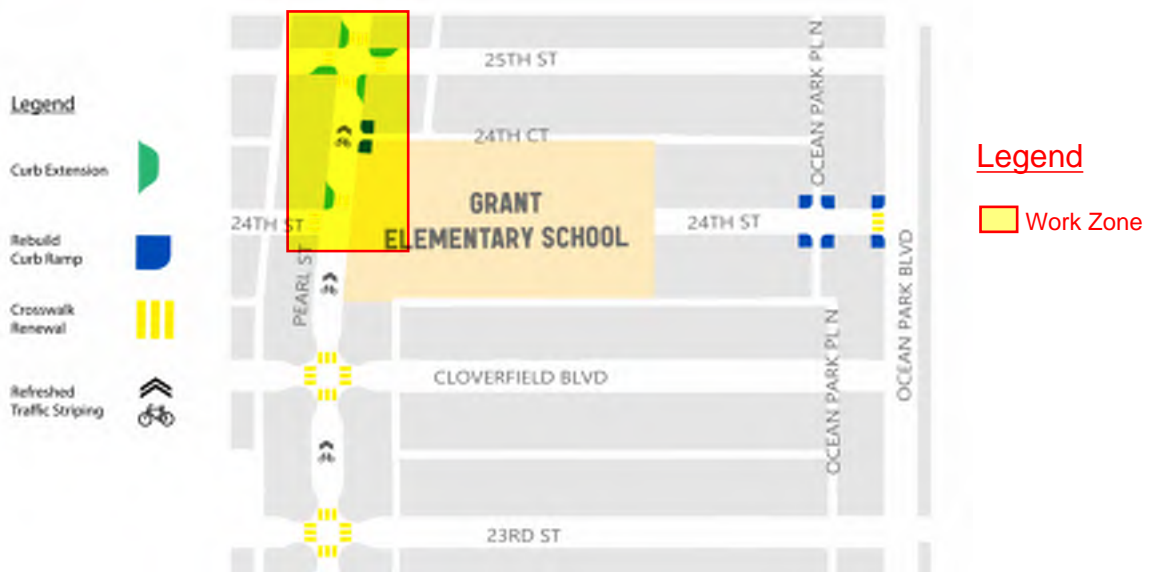
Description: Curb ramp improvements

Work Hours: 9AM – 5PM; Monday - Friday

Dear Neighbor,

The City of Santa Monica has contracted with Environmental Construction Inc for the safe routes to school pedestrian improvements project. The project will replace the existing curb ramp near your property with an enhanced version to improve pedestrian access to nearby Grant Elementary School.

There will be traffic and parking impacts and the operation of heavy equipment necessary to construct this project will create intermittent loud noise.






**Construction Period:** Construction will take place between the hours of 8AM – 6PM, Monday through Friday. Please note that the start and completion time/date of construction may be delayed due to unforeseen conditions and weather.

**Traffic Impacts:** During the construction, traffic at the project locations will be impacted and at times reduced to one lane or closed with detours. Please follow all construction signs. Portions of sidewalk may be closed. Access to driveways will remain open during the project unless work is taking place directly in front of a driveway. On that occasion the property owner will be notified directly by the Contractor.

**Parking:** Parking around the work area may not be permitted. No parking signs will be placed in areas where parking will not be allowed.
