


- 1. Special Agenda Items
 - a. Discussion and possible action regarding Santa Monica ADA/Section 504 Coordinator position(s) with guest Alex Elliot, Chair of the Disabilities Commission



- 4. Continued Items
 - a. Discussion and possible additional recommendations to City Council/SMHA Board regarding best means of facilitating a functioning SMHA Resident Advisory Board (RAB)

Commissioner Evarts motions to adopt the recommendations as described in the last 20 minutes or so, including the affirmation of Vice Chair Marasco, Commissioner Hilton, and Chair Gray as constituting a CAB Housing Commission Subcommittee. Seconded by Commissioner Gomez.

- Recommending a CAB instead of a RAB to involve most possible people.
 - 7-15 people is initial recommendation but will allow new formed group to decide number of representatives
- Want the housing authority to set the initial meeting and send out invitation to everyone.
- Would like a Housing Commission Subcommittee to be at the CAB meeting to be a resource for them.
- Invite Denise McGranahan, or other reasonably independent legal services, to be legal resources to them
- CAB is to be created as a resident organization that represents the interests of the Santa Monica Housing Authority program participants at large and participates in the annual and five-year planning process.
- Recommend a mission along the lines of insuring that the Housing Authority Clients Actively participate in the decision-making process regarding Housing Authority Policies and Procedures and are actively engaged in their community
- CAB Propose its own annual budget, however they recommend that the Housing Authority cover the cost of a website, domain name and host so that the RAB members can have email addresses that are not with the City. Outlay for the initial website design. A dedicated Phone number with TDD and TTY accessibility. Covering 1-2 surveys a year to all clients. Agreeing to a physical City mailbox. Cover the cost of a zoom account for meetings and an online fax account. Translation support at meetings as needed. Mailing costs. CAB materials (information about the CAB) be included in all new client onboarding materials.
- CAB should adopt their own bylaws that should then be included in the administrative plan.




- Recommend that the CAB, in consultation with the legal resources that we are offering them or others, create a memorandum of understanding between them and the Housing Authority Board and possibly the Housing Authority. Also recommending that the MOU be incorporated into the Housing Authority Board Bylaws and the administrative plan in its entirety.
- Recommend that they offer a \$50 stipend for CAB per meeting
- Staff are not required for any meetings and should not be there unless invited. All of this will be paid for by Housing Authority (federal money)

- b. Presentation, discussion, and possible adoption of Ad Hoc Work Plan Subcommittee proposed Housing Commission 2022-2023 Work Plan
 - Commissioner Hamilton motions to remove items 1.3 in it's entirety and 2.1a and 2.1b from the work plan. Seconded by Commissioner Hilton.
 - Chair Gray states that it is a clear conflict of intertest that Commissioner Hamilton is involved with this Work Plan section, and will reject his motion on the basis of conflict of interest. Commissioner Gomez also states that it is a clear conflict of interest. This is a matter for the City Attorney's Office.
 - Commissioner Hilton: "Yes, I'd like to offer the motion, but stated differently, that our mission statement, our Housing Commission mission statement, says we support a variety of housing types. Project housing is not defined as segregation. In fact, it helps to integrate neighborhoods and the city, and it's an alternative, an option to inclusionary and rental subsidies. So I would motion the same as the commissioner that 1.3 A, B, C and 2.1 A and B, we delete them from the work plan. Thank you "
 - Chair Gray has stated that she will exclude Commissioner Hamilton from this vote and participation in this motion, which includes the ability to second.



- There is no second. The motion fails.
- Commissioner Borresen motions to propose an amendment to determine a Santa Monica AMI being added as 1.1a; the current "a" becoming "b", and the current "b" becoming "c". Second by Vice Chair Marasco.






