Commissioner Einbinder moved and Commissioner Manvel seconded a motion to approve the Human Services Commission Bylaws with the following edits: Rule 2 – revise to indicate that meetings occur quarterly and specify the four months when the meetings take place; Rule 7 (f) – capitalize 'Consent Calendar' in the last sentence and add a period; Rule 8 & Rule 10 – change 'Secretary' to 'Staff Liaison'; Rule 13 (c) – add comma after 'raised by another member'; Rule 16 Registration (a) – in the last sentence, add 'the' after 'may only be heard with'.
