A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MONICA ACCEPTING THE LOS ANGELES COUNTY REGISTRAR RECORDER/COUNTY CLERK'S OFFICIAL CANVASS AND OFFICIAL STATEMENT OF VOTES CAST FOR THE CONSOLIDATED MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2024, AND DECLARING THE RESULTS THEREOF

WHEREAS, a consolidated General Municipal Election was held in the City of Santa Monica on November 5, 2024, as required by law; and

WHEREAS, the provisions of the Elections Code of the State of California for the holding of elections in Charter cities were complied with in that notice of the election was given in the time, form, and manner as provided by law; voting precincts were properly established; election officers were appointed and that in all respects the election was held and conducted; votes were cast, received, and canvassed; and the returns were made and declared in the time, form, and manner as required; and

WHEREAS, the Los Angeles Registrar/Recorder/County Clerk canvassed the returns of the election and certified the results to the City Council, and those results are attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SANTA MONICA DOES RESOLVE AS FOLLOWS:

SECTION 1. The vote totals for the Consolidated Municipal Election held on November 5, 2024, in the City of Santa Monica, as certified by the Los Angeles County Registrar Recorder/County Clerk, shall be and hereby are approved and adopted as the

formal vote count of the City of Santa Monica for said offices and said measures of said election.

SECTION 2. The names of the candidates on the ballot were:

SECTION 3. There was a scheduled election to fill three seats on the Santa Monica College Board of Trustees, however, the number of qualified candidates did not exceed the number of seats to be filled. The Santa Moncia College Board of Trustees Election was cancelled as provided in Section 5328 of the California Education Code and the qualified candidates will be seated at the Board's next scheduled meeting. The qualified candidates are Anastasia Foster, Rob Greenstein Rader, and Margaret Quinonez-Perez.

SECTION 4. There was a scheduled election to fill two seats on the Santa Monica Rent Control Board, however, the number of qualified candidates did not exceed the number of seats to be filled. The Rent Control Board election was cancelled as provided by Article XVIII, Chapter 1803(d) of the Santa Moncia City Charter, and qualified

candidates shall be seated upon swearing in by the City Clerk. The qualified candidates are Kay Ambriz and Phillis Dudick.

SECTION 7. Three measures appeared on the ballot.

The first measure read as follows:

MEASURE F

To fund essential city services such as 911 emergency response, public safety, and addressing homelessness, shall the measure modernizing the City of Santa Monica's 1990 business license tax ordinance to improve tax equity and fairness, exempting small businesses from the tax, decreasing tax rates for most retailers and restaurants, raising the corporate headquarters rate to 0.25%, removing auto dealer tax exemptions, and restoring a business license processing fee, generating approximately \$3,000,000 annually, until ended by voters, be adopted?

The measure received votes as follows:

Measure F was approved by the voters by the following votes:

The second measure read as follows:

MEASURE K

To enhance public safety, create safe routes to school to protect children, lower the risk of fatal traffic accidents, and maintain other essential city services, shall the measure increasing the City of Santa Monica Parking Facility Tax by 8% for users including visitors and tourists, causing no additional cost in City-owned lots and structures (including downtown and the beach) because of a partial City exemption, generating approximately \$6,700,000 annually until ended by voters, be adopted?

The measure received votes as follows:

Measure K was approved by the voters by the following votes:

YES VOTES	34,669	74.26%
NO VOTES	12,014	25.74%

The third measure read as follows:

MEASURE PSK (Advisory)

ADVISORY VOTE ONLY: If Measure K is enacted, should at least half of the additional revenue raised be used to protect public safety in Santa Monica,

including attracting and retaining well-trained police officers and firefighters, improving crime and homelessness prevention services, and increasing police patrols and enhancing emergency medical response in neighborhoods and public areas, including downtown, the pier, and the beach?

The measure received votes as follows:

Measure PSK (ADVISORY VOTE) was approved by the voters by the following votes:

YES VOTES 30,409 67.21% NO VOTES 14,836 32.79%

SECTION 8. The City Clerk shall enter on the records of the Santa Monica City Council, a statement of the result of the election showing: (1) the total number of votes cast for the offices and the measures in the election; (2) the names of the persons voted for; (3) the text of the measures voted upon; (4) the office that each person was running for; (5) the number of votes given at each precinct to each person, and for and against each ballot measure; and (6) the total number of votes given to each person, and for and against the ballot measures.

SECTION 9. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated. The City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have each person subscribe to it and file it in the office of the City Clerk. All of the persons so elected shall then be inducted into the office to which they have been elected.

SECTION 10. The City Clerk shall certify to the adoption of this Resolution, and thenceforth and thereafter the same shall be in full force and effect.
